



## FINDAWAY ONE-YEAR LIMITED WARRANTY

Findaway's warranty obligations for the Playaway View™ product are limited to the terms set forth below:

When delivered to you in a new condition in its original container Findaway World LLC ("Findaway") warrants the Playaway View™ product against defects in materials and workmanship for a period of one (1) year from the date of original purchase ("Warranty Period").

If a defect arises and a valid claim is received by Findaway within the Warranty Period, as its option, Findaway will (1) repair the product at no charge, using new or refurbished replacement parts, (2) exchange the product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product.

If a defect arises and a valid claim is received by Findaway after the first one hundred and eighty (180) days of the Warranty Period, a shipping and handling charge will apply to any repair or exchange of the product undertaken by Findaway.

Findaway warrants replacement products or parts provided under this limited warranty against defects in materials and workmanship from the date of the replacement or repair of ninety (90) days or for the remaining portion of the original product warranty', whichever provides longer coverage for you. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes Findaway's property. When a refund is given, your product becomes Findaway's property.

### Exclusions and Limitations

This Limited Warranty does not apply to any non-Findaway hardware product, even if packaged or sold with the Playaway View™ product, including, without limitation the power adapter.
